## Japan Pre-Entry Tuberculosis Screening (JPETS)

According to the Ministry of Health, Labour and Welfare (MHLW), individuals who meet the following criteria are required to undergo a chest x-ray examination, etc. at a designated Panel Clinic and promptly submit the necessary documents before arrival to Japan. Please check the details in advance.

## 1. Applicants subject to JPETS:

Individuals who hold citizenship of the Philippines, Vietnam or Nepal and are planning to stay in Japan with either a short-term stay visa or a student visa (for more than 90 days).

\*Indonesia, Myanmar, and China are also expected to be included in the near future, but the start date has not yet been determined.


